Tent City: Refuse to Retreat

For four months now the Victory Squat has stood strong. While enduring attacks from all levels of government and the police, the Tent City continues to provide safety and solidarity for those most brutalized by the BC Liberals. Throughout all

the small struggles waged by the squatters the two demands remain the same: social housing for all in need and end the welfare time limit immediately!

Over 25% of Vancouverites qualify for social housing but still there are no units available. The federal Liberals have not invested a cent since 1993 and it was a top priority for Gordon Campbell and his thugs to scrap any new plans for decent housing. At

this time COPE has done little to nothing to deal with our housing crisis. Although they own the W o o d w a r d 's building, they are

planning on making only 100 out of the 450 units into subsidized housing. This is an insult to those of us who fight for social justice. The people fought for Woodard's and Woodward's belongs to the people.

We demand Woodward's be given to those in need. All of it! COPE must provide the units and the Liberals must subsidize them. The necessity of social housing has been highlighted by the Liberals threatening to steal the cheques of welfare recipients this April 1st. If they are allowed to carry through with their welfare time limits, the crisis poor people live and die through already will intensify. Their strategy of throwing tens of thousands of men, women, and children off of welfare and into a rapidly depleting job market, makes good business sense for the Liberals' financial backers. Within the onslaught of cuts, privatization, the six dollar training wage, the tearing up of contracts and all other crimes perpetrated so far by the Liberals, adding thousands to the ranks of homelessness will drastically undermine the working classes' power in bargaining.

set on going through with the welfare cuts regardless of the cries coming from the poor. Gradually the people of this province are beginning to understand the consequences of this upcoming catastrophe. They are

studying statistics and making reports. Political parties like the NDP who threw women and children off of welfare and into the streets during their reign are saying NO to the cuts. Politicians that long abandoned the poor are saying NO in meetings not attended by the poor. Almost everywhere, everyone is saying NO but NOTHING is being done.

The Liberals have already thrown at least a hundred

Because poor people are fighting back! Before the construction of the Victory Squat by the APC, the welfare time limit wasn't on anyones political Horizon. We forced the people of this province to take a stand. The squatters have stood for four months, victoriously fighting for their rights and dignity. Welfare recipients have mobilized marches through the financial district and sent flying squads into welfare offices. Advocates are participating in direct casework, action different organizations have formed coalitions and are creating collective strategies to destroy the two year time limit!

APC has been active in all these things. Where poor people are struggling we stand with them, not in sympathy but militant solidarity! We are becoming a fighting force to be reckoned with and need everyone's support. The real time limit is how long until the working people of BC say "ENOUGH! We refuse to retreat! We will fight together. We will fight to win!" When that time comes we will defeat the Liberals and create a real movement that will destroy oppression.

Cheam Update

On October 30th, the defenders of Elk Creek, scattered saw dust, the remains of a Cheam First Nation sacred site, throughout the office of Cattermole Timber in Vancouver. APC member and native forest defender, James Mickelson explained that,"This is also an answer to Cattermole Timber's campaign of physical intimidation against peaceful forest defenders, and to the politicians who refuse to take steps to resolve this issue, or even engage in dialogue . . . Your thug tactics will not keep us from voicing our opposition and from acting against this injustice."

Safe Site: Six Month Success

The user-run injection site announces its victory and success in operating a peer-driven supervised injection site for six months.

Since April 7, 2003, the User/Peer Group has successfully operated a supervised injection site and drop-in centre for the people of the Downtown Eastside. The site was opened to:

1. Address the dire and largely ignored health needs of injection drug users in the Downtown Eastside

2. To put direct pressure on all levels of government to establish a supervised injection site in the DTES

3. To protect drug users and people who live in poverty from the Vancouver Police Department, who initiated a large-scale crackdown on residents of the DTES - a crackdown that has had severely negative health impacts for drug users, and their access to essential health care.

Community members, drug users, and other supporters of harm reduction opened the site where drug users could inject drugs safely, have access to sterile injecting equipment, access medical attention as necessary, and escape police brutality. Despite repeated harassment from the Vancouver Police Department, the site operated for six months from 10pm to 2am, 7 days a week.

The preliminary results from our evaluation of the site shows that the site provided an important public health and community benefit. During the past six months, a total of 3614 injections were safely supervised at the injection site, and on average, 194 sterile syringes were distributed during the four hours of operation each night. Three hundred and forty-nine different individuals accessed the site, 87% of which were people who previously injected in public spaces - a practice that has been shown to be associated with a high risk for disease transmission, overdose, and other health-related harms. In addition, no overdoses occurred during the operation of the site.

The site, unlike the newly opened government-run site, maintained a community based user-run format, and was able to accommodate all those who came to use the site including the 12% of visitors who came to the site requiring assistance with injections.

While we support the opening of the government-run site, we want to emphasize that the new site is, in many ways, unlike the community based user-run site that we operated for the last six months.

We are now very concerned about the well being of many individuals. particularly women who require assistance with injection, who now have no place to inject safely. Therefore, we are urging the Vancouver Coastal Health to adopt the peer-based format that we successfully implemented at the userrun site. Our experience has demonstrated this format is feasible, safe, and the most effective way to accommodate those most at risk.

Our experience at the user-run site has also further confirmed the findings of recent research studies that have revealed the severely negative effect that the Vancouver Police Department's crackdown is having on access to health care, and the health of individuals living in the Downtown Eastside. Throughout the operation of the user-run site, attendance and access to sterile syringes fluctuated substantially in accordance with the level of police interference. The police repeatedly parked cruisers outside of the site, harassed those trying to access the site, and on one occasion entered the site illegally, without due cause or an appropriate warrant. Due to escalating

police threats and harassment and under threat from the City of Vancouver, we were forced to close 327 Carrall User Run Injection site, sadly we know this will come at the cost of drug related harm to our sisters and brothers. We thank all our supporters and all the volunteers who worked night after night at 327 Carrall. We will continue to organize as a peer group and fight for the rights and dignity of drug users and those who live in poverty.




